**BRAHMS: Symphony No. 3** 

1st mvt: m36 - 46 2nd mvt: m1 - 22

\*KODÁLY: Dances of Galánta, m31 – 65

MENDELSSOHN: Scherzo from Midsummers Night Dream (complete) \*RAVEL: *Bolero* opening solo, 3<sup>rd</sup> measure of rehearsal 1 – rehearsal 2

\*RESPIGHI: Pines of Rome, 3rd mvt (complete)

\*SHOSTAKOVICH: Symphony No. 9

2nd mvt: m1 - 32 3rd mvt: m1 - 17

STRAVINKSY: The Firebird Suite (1919 version)

Introduction: "Variation de l'oiseau de feu", rehearsal 9 to end of movement (please play a half-step trill 2 measures before rehearsal 16)

2nd Clarinet Excerpts (may be played with 1st Clarinet at audition)

\*BARTOK: Concerto for Orchestra

2nd mvt: Giuoco delle Coppie, m45 - 57

**BRAHMS: Symphony No. 3** 2nd mvt: m1 - 22

**DVORAK: Symphony No. 8** 

2nd mvt: Adagio (complete)

MENDELSSOHN: Scherzo from Midsummers Night Dream (complete)

MENDELSSOHN: *The Hebrides* ("Fingal's Cave")

Duet: m202 – 217, or 25<sup>th</sup> measure of F – Animato

\*SHOSTAKOVICH: Symphony No. 1

2nd mvt: rehearsal 8 - 10 4th mvt: rehearsal 6 - 9

\*SHOSTAKOVICH: Symphony No. 10

1st mvt: 7th measure of rehearsal 56 until rehearsal 59

TCHAIKOVSKY: Symphony No. 5

1st mvt: m1 - 37

3rd mvt: m96 - 118, or rehearsal F - H
